# THE TOWN OF MILLVILLE'S COMMUNITY CHOICE POWER SUPPLY PROGRAM CONSUMER NOTIFICATION

October 2, 2017

Dear Millville Basic Service Consumer:

The Town of Millville is pleased to announce that NextEra Energy Services (“NextEra”) has been selected as the supplier for its Community Choice Power Supply Program (“Program”). This Program is a municipal aggregation which enables local government to combine the purchasing power of its residents and businesses to provide them with an alternative to National Grid Basic Service (M.G.L. c. 164, § 134). This Program only affects the supply portion of your monthly bill. It will not affect the delivery portion of your monthly bill. National Grid will continue to deliver your electricity but Millville has chosen the supplier for the Program. NextEra will provide electric power supply for all consumers currently on Basic Service in Millville. This letter is intended to tell you about this Program for electric power supply. In accordance with state law, it also informs you of your rights and options if you choose not to participate in the Program.

**YOU WILL NOT NOTICE ANY CHANGE IN YOUR ELECTRICITY SERVICE.** The only difference you will see is that NextEra will be printed under the “Supply Services” section of your monthly bill. You will continue to receive one bill from National Grid. You will continue to send your payments to National Grid for processing. National Grid will continue to respond to emergencies, read meters and maintain the distribution and transmission lines. Reliability and quality of service will remain the same. Furthermore, you will continue to have all existing consumer rights and protections.

### IMPORTANT INFORMATION

- **YOU WILL BE AUTOMATICALLY ENROLLED IN THIS PROGRAM** unless you choose not to participate and opt-out.
- At Program launch, the Residential and Commercial aggregation rate is lower than National Grid’s Basic Service rate. However, **THIS DOES NOT GUARANTEE FUTURE SAVINGS**. The aggregation rate is fixed for 12 months (November 2017 to November 2018) while National Grid’s Basic Service rate changes twice a year, in May and November. As a result, the aggregation rate may not always be lower than National Grid’s Basic Service rate. The goal of the aggregation is to deliver savings over the life of the Program against National Grid’s Basic Service rate.
- There is **NO PENALTY CHARGE TO OPT-OUT** of the Program and return to National Grid Basic Service.

**IF YOU HAVE BEEN MAILED THIS NOTIFICATION** you do not need to take any action to participate in the Program.

**ALL BASIC SERVICE CONSUMERS** who have been mailed this notification will be AUTOMATICALLY enrolled in the Program and start benefiting from the aggregation rate beginning on the day of the month in November 2017 that your meter is read. This date varies by service area. Your meter reading date is shown on your bill.

**WATCH YOUR NATIONAL GRID BILL FOR FURTHER NOTIFICATION** of the Program.

- Your November 2017 bill will state that you are being switched to Millville's Program.
- Your December 2017 bill will show Millville's supplier and aggregation rate under "Supply Services".

**BUDGET PLAN OR ELIGIBLE LOW-INCOME DELIVERY RATE CONSUMERS** will continue to receive those benefits from National Grid.

**SOLAR PANEL CONSUMERS** will continue to receive their net metering credits while benefiting from the aggregation rate.

**TAX EXEMPT SMALL BUSINESS CONSUMERS** must send or email a copy of their Energy Exemption Certificate directly to NextEra Energy, Attn: CAM Team – Tax Exempt Certificates at 20455 State Highway 249, Houston, TX 77070 or [email.Taxinbox@gexaenergy.com](mailto:email.Taxinbox@gexaenergy.com) (email) in order to maintain their tax exempt status.

**IF YOU HAVE ALREADY CHOSEN A COMPETITIVE SUPPLIER ON YOUR OWN** you must opt-out of this Program. This will ensure you continue to get your electricity from that Competitive Supplier.

**IF YOU HAVE ALREADY CHOSEN A GREEN POWER SUPPLY OPTION ON YOUR OWN** you must opt-out of this Program. This will ensure you continue to get your electricity from that Green Power Supply.

**IF YOU DO NOT WISH TO PARTICIPATE IN THIS PROGRAM** you may: 1) Opt-out and continue paying National Grid's Basic Service rate; or 2) Opt-out and choose your own Competitive Supplier (if one is available to you).

#### **HOW TO OPT-OUT**

- Sign and return the enclosed opt-out card in the postage paid envelope provided; **OR**
- Visit [www.colonialpowergroup.com/millville/](http://www.colonialpowergroup.com/millville/) and click the opt-out button, then fill out and submit the Opt-Out Form; **OR**
- Call NextEra at (855) 639-8121 and ask to remain on National Grid Basic Service.

**ANY TIME AFTER ENROLLMENT** you can still opt-out with NO PENALTY CHARGE. It may take a couple of billing cycles before you are back on National Grid Basic Service. If you choose to opt-out after the initial enrollment, you may submit an Opt-Out form at [www.colonialpowergroup.com/millville/](http://www.colonialpowergroup.com/millville/) **OR** call NextEra at (855) 639-8121 and ask to be placed on National Grid Basic Service.
