Motor Vehicle Excise Abatements – *On a motion by Furno and second by Monroe, the Board votes unanimously to sign Motor Vehicle Excise Abatement Applications.*

Certification of Excess/Release of Assessors Overlay Surplus Funds – *On a motion by Alward and second by Monroe, the Board votes unanimously to certify the amounts of excess in the Assessors Overlay Accounts, as provided by the Town Accountant, to be \$643.28 in FY 2006 and \$21,687.22 in FY 2008. On a motion by Furno and second by Monroe, the Board votes unanimously to release from this surplus, the total sum of \$22,330.50, as per the Board of Selectmen's request and the Finance Committee's recommendation in order to supplement the town's FY 2016 budget.*

RE/PP Tax Abatement Applications – *The Board reviewed the Real Estate and Personal Property Abatement Applications. On a motion by Monroe and second by Furno, the Board votes unanimously, as per Ellis Withington of Mayflower Valuation's recommendation, to approve and sign six (6) applications, four (4) being approvals and two (2) being denials and to also sign the corresponding Real Estates and Personal Property Tax Abatement Certificates/Denials.*

Motor Vehicle Commitment Book – *On a motion by Alward and second by Furno, the Board votes unanimously to sign the 2015.2 Motor Vehicle Commitment Book.*
