Food Permit-St. Augustine's Church:

Dustin Ciccarelli met with Ray Berthelette in regards to the food permitting process with the Town.

Mr. Berthelette had many questions about food permits needed for non-church functions held at the church. D. Ciccarelli believed that entities that use the church for other functions such as the scouts are not included under St. Augustine's food permit. St. Augustine's food permit would be strictly for their use only.

Mr. Berthelette questioned that if the commercial stove was replaced with a regular kitchen stove, would the hood have to be cleaned and how often. D. Ciccarelli stated that he will defer that question over to the health inspector and get back to him with the answer.

Mr. Berthelette also would like to be notified when inspections are needed as he would be the person to provide access to the kitchen. Otherwise, the inspector may show up and no one will be able to let the inspector in to the kitchen area.

Mr. Berthelette also wanted to inform the Board of Health that a few individuals are taking the classes for CPR and Anti-Choking that are required and will supply the Board with the documentation when the classes are completed.

17 Fletcher Ave:

The secretary to the Board informs D. Ciccarelli that a letter was sent certified mail to the owner of 17 Fletcher Ave in regards to the (3) unregistered cars on the property that are located close to the wetlands. The Board would like the cars removed so that the possibility of contamination from oil etc. do not affect the wetland areas.

<u>Andy's Auto Sales</u>: A Business Certificate comes to the Board form the Town Clerk requiring a signature of the Board of Health – Andy's Auto Sales. The Board signed off of the Business Certificate but it seems that this applicant may need a Class II License with inspections by the Board of Health.
