

TOWN OF MILLVILLE BOARD OF SELECTMEN Minutes of Monday, March 5, 2007

• John Dean, Highway Department:

Landfill:

John conveyed to the Board that there is water from the landfill leaking into the salt shed.

Bridge:

John provided pictures of the bridge, which showed a portion of a wall caving in. The Board of Selectmen will be bringing this up at the March meeting with Mass Highway.

Main St. Plowing:

It was brought to John's attention that there was some property damage from the plows on Main St. John has spoken with the property owners along with addressing this with the plowing company for the State.

EXECUTIVE SECRETARY:

• The Call

Since The Call newspaper had recently sold, the paper has been covering exclusively Rhode Island. After speaking with a representative at the paper the coverage will again start in Massachusetts.

• 100 year celebration:

The Town is not allowed to start putting aside money for this event until five years prior to the anniversary, but the Town may accept donations.

• Flooding Issue:

Chief Landry assisted with a flooding issue on Granite Circle. It is the opinion of the Highway Surveyor that there needs to be 2 catch basins on Granite Circle.

• Tree Removal:

National Grid will be tagging the trees around Town that are a hazard.

• Stormwater:

A meeting will be set up with the Board of Health, Conservation, Planning Board, and Highway Department to discuss the compliance with Stormwater.

• Millville Elementary School:

There will be another abbreviated testing the end of March and a meeting of the engineers and water operator scheduled with the BOS upon getting the results.

Emergency Hydrant Replacement:

The Board of Selectmen recommended that Chief Mullaly keep a list of available contacts to use for emergency situations in regards to the hydrant replacements. This list should also be forwarded to dispatch.

• Cable Commission:

The Board of Selectmen would like Helen to send another letter to the Cable Commission inquiring about the status of equipment.

<u>Disposal of Videos:</u>

The library is housing over ten years of VCR tapes. There is currently not storage to house anymore.

On a motion made by Paul Savage, and seconded by Tom Petrowicz, the Board of Selectmen voted <u>unanimously</u> to destroy all meeting tapes up to three years ago making sure that no special event tapes are destroyed.



TOWN OF MILLVILLE BOARD OF SELECTMEN

Minutes of Meeting w/Fire Chief Monday, March 5, 2007

Members Present: Chairperson Diane McCutcheon, Vice Chairman Paul Savage and Selectman Tom Petrowicz.

Also Present: John Mullaly, Fire Chief

The Board meets with the Fire Chief Mullaly to discuss his current and future budget requirements and staffing needs.

The parties review the budget as it pertains to vehicle maintenance and equipment. Discussion follows regarding the budget shortfall due to vehicle maintenance and fuel expenses. The Chief indicates that an additional \$8,000 will be required. The Board questions the maintenance of the vehicles -- the Chief explains that the full-timers maintain the older vehicles and take care of the smaller items in-house; however, the larger and newer vehicles are sent out for maintenance. The Chief mentions that the warranties/guarantees on the vehicles have now run out.

The Board reviews the monthly staffing updates provided by the Chief. The Chief's recommendation is to implement a third full-time position. Discussion follows regarding the current morale and working conditions at the Fire Department. The Chief expresses his concerns regarding certain employees and various instances. The Board emphasizes that the Chief needs to get a better handle on the employees and discontinue any dissention of rank. Selectmen Savage offers to assist the Chief and meet with the employees, if necessary. Brief discussion regarding the new full-timer just hired – the Board would like to meet him at the next regular Board meeting.

The Board would like to meet with the Chief again on Monday, March 19th at 6:00 to continue the discussion. In the meantime, the Chief will prepare a Warrant Article for the third full-time position.

Meeting adjourns at 7:00 p.m.
