# TOWN OF MILLVILLE BOARD OF SELECTMEN Minutes of May 21, 2007 5:30 p.m.

# **BUSINESS RETENTION GRANT**

Members Present: Chairperson Diane McCutcheon, Vice Chairman Paul Savage, Tom Petrowicz, Charlie Poulin and Karin Furno.

Others Present: Executive Secretary Helen Coffin, Todd Gleason of Blackstone Valley Chamber of Commerce Economic Development Committee

Chairperson McCutcheon called the meeting to order at 5:43 p.m.

The Board is meeting to discuss the \$75,000 Business Retention Grant that the Town has received. Several Town residents and business owners were invited to attend the meeting for their input. The purpose of this meeting is to finalize how the Town will spend the grant monies.

Chairperson McCutcheon summarizes the Board's proposal previously sent to the Economic Development Committee which was decided based on input received from residents and business owners at a Board of Selectmen meeting last month.

Mr. Gleason explains that the Economic Development Committee reviewed the proposal and believes all the ideas are good ones. He explains that they would like the Town to use the funds in a way that would most benefit the Town and have a long-range affect. He further explains the initiative of the Four Town Board of Selectmen Group, consisting of Uxbridge, Sutton, Northbridge and Douglas. A representative of the Four Town Board of Selectmen Group was present to explain the benefits of regionalization and the effects of that recent building has had on the Rt. 146 area. Mr. Gleason feels it is a good idea for Millville to become a member of this Group and suggests using some of the grant monies of pay the fee to join. This would show the Town's commitment to working on regional issues and will magnify the voice of the towns. Chairperson McCutcheon states that she supports regionalization and is willing to address the Four Town Group another time, however, feels that the reason why we are at this meeting is to discuss the current proposal as presented.

Mr. Gleason would like to review the proposal in more detail and hammer down the numbers. The Town will need to identify the scope of work required: how many signs and what type of signs we would like and where they will be placed; what type of lighting and where it will be installed; how would we go about starting a link for the website. We need to prepare an estimate of the costs/budget involved.

Resident Margaret Carroll believes much of this information may be found in the Land Use Master Plan. Helen Coffin will obtain a copy of that Plan. Helen should also obtain a copy of the Plan for the center of Town upon completion of the bridge.

Mr. Gleason will let us know if the grant monies will allow for signage for existing businesses or for start-up capital.

He would like our information by the end of the first week of June, if possible.

The Meeting adjourned at 7:00 p.m.

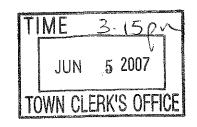

Chairperson McCutcheon called the meeting to order at 7:00 p.m.

#### **ANNOUNCEMENTS:**

- Congratulations to the Millville graduating seniors.
- Thank you to all that attended the Town Meeting.
- Thank you to the Board of Health, Conservation Commission, and Boy Scouts for a successful town clean-up day.
- The Memorial Day Parade is scheduled for Monday, May 28, 2007. The line up will start at 1:00 at Central and Providence Streets.
- A memo about evasive stilt grass was provided to the Town. There will be representatives who will be spraying the town with herbicides to get rid of this grass.
- The Board of Selectmen held a meeting about the Business Retention Grant in the amount of \$75,000.
- There continues to positions available on boards and committees.

# **GOOD & WELFARE:**

- Resident, Norman Thuiot, wanted to know:
  - Who is the Town's liability counsel?

The Executive Secretary responded, MIIA.

Selectmen Savage stated that the Conservation is filing an appeal against the Planning Board. The Town has always given the Town boards attorneys when needed.

- On a motion made by Karin Furno, and seconded by Charlie Poulin, the Board of Selectmen voted <u>unanimously</u> to authorize the Chairman to sign the change order.
- Board of Health Cell Phone:

On a motion made by Karin Furno, and seconded by Charlie Poulin, the Board of Selectmen voted <u>unanimously</u> to authorize the purchase of one cell phone for the Board of Health.

Audit:

The auditors will be at the next meeting on June 4, 2007.

# **OLD BUSINESS:**

• Open Space Residential Design

The Planning Board wants comments and suggestions on this draft bylaw.

• Personnel Policies and Procedures:

Selectmen Furno removed herself from this discussion.

The Board of Selectmen discussed the personnel policy section which references employees if the Town who are elected to serve on another position leaving employment. The Board of Selectmen discussed that they have the option to choose to impose or not to impose this policy. It was the opinion of the board that by imposing this it would be a detriment to the Town since it is difficult to get people to even run for elected seats.

On a motion made by Paul Savage, and seconded by Tom Petrowicz, the Board of Selectmen voted <u>unanimously</u> to remove this policy. Selectmen Furno abstained.

## Personnel Policies and Procedures Sections # 1-4.

The Board of Selectmen wants to give these policies and procedures to the various boards and departments for review and comments. The Board of Selectmen will be reviewing pages 28 -56. A public hearing will be held.

#### **NEW BUSINESS:**

## • Request for Special Counsel of Planning Board:

Chairperson McCutcheon left the room during discussion.

Selectmen Furno disclosed that her husband is on the Planning Board but she feels that she can render an objective decision.

Selectmen Poulin informed the Board that he has done work for the family involved and also spoke with the ethics commission and was advised that he could in fact discuss and vote on this issue.

Selectmen Petrowicz stated that he did receive and read the information provided and believes that this is not going to be long term litigation and it is standard procedure and suggested a \$1,000 cap on this item.

Selectmen Poulin wanted to know why the Board of Selectmen wants to put a cap on this?

Selectmen Savage stated that it has happened before that one board has taken another board to court. He wants to make sure that if the Planning Board exceeds the \$1,000 then they must come to the Board again.

On a motion made by Tom Petrowicz, and seconded by Karin Furno, the Board of Selectmen voted <u>unanimously</u> to provide authority the Planning Board for special counsel with a cap not to exceed \$1,000.

# **Annual Town Meeting:**

- The classification plan was approved.
- No outstanding bills.

#### **Board of Assessors:**

The Board of Selectmen received a memo from Board of Assessor's. The Executive Secretary will provide a written comment in regards to the Assistant Town Clerk's duties.

#### Landfill:

The Town has received no further information from BATG. The contract with the environmental specialist has never been received. Attorney Pickett is working on this.

A notice came from consultant Tata & Howard informing the town that \$51,000 has been spent to date and the contract for the closure of the landfill was not to exceed \$54,000.

The Board of Health representative, Dave Stanley, mentioned that Tata & Howard had a voucher that needed to be signed. The Board of Health is going to hold the voucher until further clarification of work is explained.

There will be another meeting tentatively set up for June 4, 2007 with all members. The Board of Selectmen would like to have an update from DEP.

#### **OLD BUSINESS:**

#### Bylaws and immediate needs for Town:

- 1. Cell Tower
- 2. Adult District Bylaw must be placed in town. This should be on the books. Selectmen Savage provided the standard language of such a bylaw. He suggested that this bylaw be co-sponsored with the Zoning/Planning Board for the next Annual Town Meeting.

#### Park Complaint:

• There was a complaint about older children hanging out and using foul language at the park area. The Millville Police Department was notified.

#### Senior Center

- The tentative open house date will be June 24, 2007.
- Thank you to Selectmen Poulin for offering his plumbing services. Also thank
  you to Board of Health Chairman, Dave Stanley for offering his electrical
  services.
- The Executive Secretary will be writing a letter of thanks and termination at the old Senior Center.
- Gerry Finn has confirmed that the cabinets will be done by June 24, 2007.

## Quilt Appraisal:

 On a motion made by Paul Savage and seconded by Tom Petrowicz, the Board of Selectmen voted <u>unanimously</u> to have both town quilts appraised and insured.

## **Chestnut Hill Meeting House Association:**

• The Board of Selectmen will be holding their monthly meeting at the Chestnut Hill Meeting House on September 4, 2007.

#### **Town Beautification:**

• Chairperson McCutcheon had an idea of having local businesses sponsor and provide plants to various areas in town. The businesses would display their business sign along with upkeeping the area.
