# **BOARD BUSINESS:**

• Reorganization:

# **GOOD & WELFARE:**

• Blackstone River Bikeway:

Mark Jewel presented the overview of the project:

- 1. Created a task force
- 2. Created a website posted by the Chamber of Commerce
- 3. Completed the permitting form
- 4. There was a grand opening of the Bike way opening.
- 5. Ready to advertise the design segment (16 miles of bikeway)
- 6. MASS Highway will award the contract.
- 7. In the Future would like to designate a citizen advocate to the project.
- 8. The Central Street North portion of the design phase is 25% complete. This portion will be advertised in the summer.

Resident, Norman Thuot 25 Ironstone St. had several questions about the Police Chief situation and the finances.

- Wants to know how much money this is costing the town?
- Has the town been billed to date?
- Is the town being billed for Lt. Baxter's service?
- Does the town have any money set aside for an appeal process?
- Has anyone spoken with the town insurance agent?
- Do all the Boards in town use Kopelman & Paige?

The Chairperson addressed Mr. Thuot by informing him that:

- The Town is asking Kopelman & Paige to take the bills and itemize the hours.
- The cost incurred thus far for the investigation is \$3,400.00 which was approved by the Board of
- The supervisory officer in charge is not billing the town.
- The Board of Selectmen have not spoken with the insurance agent.
- There has been no money put into an account for a possible appeal.

Mr. Thuot verbally requested a copy of all legal bills from any and all law firms that the town utilizes. The Chairperson informed Mr. Thuot that the law entitles the Executive Secretary to answer the request within ten day.

Resident Roland Barrett, 52 Fisher St., wanted to know how the road flooding on Fisher St. is being addressed. It was discussed that Mr. Gamache was going to visit the area and make recommendations. The executive secretary will contact Normand Gamache from Guerriere & Halnon.

Resident, Mrs. Barrett, 52 Fisher St., presented a letter to the Board of Selectmen complaining about a situation which took place with the Chairman of the Conservation Commission during a site visit. Selectmen Petrowicz responded that this will be addressed with Mr. McCutcheon and the Board will inform the Barrett's of the outcome.



# MINUTES OF THE MEETING

APRIL 4, 2006 @6:00

The workshop opened at 6:30 due to a delay gathering a quorum.

He advises the Board of the problems he foresees down the road with respect to the Veterans budget and state reimbursement situation. He expresses his concern regarding how the Town's money is being spent with respect to Veterans services and further explains that the Town needs to make some important decisions. Discussion follows among all parties concerning the current situation relating to Veterans affairs and benefits.
