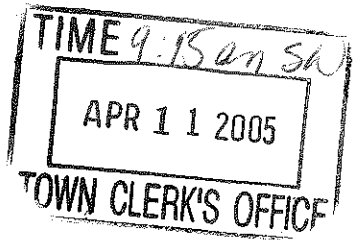


**TOWN OF MILLVILLE

### OLD BUSINESS

The salt bill for the Middle and High School was sent to the district.

The BOS will be setting up a meeting with DEP to ask for guidance with the water project at the school. The BOS met in a workshop to look at alternatives. Due to time constraints, the BOS recommended going ahead with the bidding documents.

### NEW BUSINESS

The school committee is looking at a \$370,000 increase for FY06. Diane will be asking them to go back and revisit what they proposed.

The Senior Center building committee has a total of \$40,000 collected with another \$25,000 coming. This fundraising effort will continue. Be sure to watch for upcoming events.

Sue will check to make sure the library furnace was fixed.

### GOOD & WELFARE

MaryLou Anderson wanted to inform residents that the April Earth Day Clean-Up will be Saturday, April 23, at 9:30 AM. The first 100 volunteers will receive a free tee-shirt.

On a motion made by Brian Dicks, seconded by Paul Savage, the BOS votes unanimously to adjourn the meeting to sign minutes and warrants.





On a motion made by Paul Savage, seconded by Brian Dicks, the BOS votes unanimously to close the hearing at 7:20 P.M.


