Correspondence

Executive Secretary's Report

There was a motion made by Ken Gikas to appoint Gary Fagan as the Assistant Animal Control Officer. After discussion regarding the applicant between the board and Romeo Ethier, Mike Pare seconded the motion and it was a unanimous vote.

He said whatever the outcome, he wants the neighbor to be satisfied with the end result. Ken Gikas would like to speak to the Town Counsel to see if the Town is responsible legally for this decision. Les would also like to see the dog, and would like the family to come up with a relocation plan. The Board continued the hearing to Monday, August 20, 2001 and will make a decision at 6:45 p.m.
