
TOWN OF MILLVILLE BOARD OF SELECTMEN MEETING March 17th, 2003

NEW BUSINESS

The preliminary school budget hearing will be Wednesday, March 19th at 7:00 p.m.

Paul Savage mentioned a bus situation involving his daughter and how she missed the afternoon bus. His concern was that there was no accountability on the schools part to insure the safety of those children who miss the bus. The Board would like a letter written to the school committee and all pertinent members explaining their concern for the safety of the children. The Board would also like to know how this matter is being addressed. Sue will be contacting the police department to inquire about how many students have been dropped off at the police station as a result of missing their busses.

There was a discussion about the policy for closing town hall. Diane explained that if the town hall is closed, the staff will get paid; but if an employee leaves work due to the inclement weather and the building remains opened, they will not be paid. This policy will be written up so all employees are reminded about the procedure.

The board will be creating a policy determining which employees will be getting the identification badges.

GOOD AND WELFARE

Russell Rosborough wanted to know what procedures needed to follow in order to get a license allowing him to open a garage. Sue will supply him with an application.

Karen Albright from the Senior Center building committee was asking if the board would reserve 210 Chestnut Hill Rd, for possible senior center site.

On a motion by Brian Dicks, seconded by Mike Pare, the Board voted unanimously to reserve 210 Chestnut Hill Rd. for possible senior center site as part of preparing the RFP.

The Board of Selectmen voted to go into Executive Session for Negotiations & Litigation, on a Roll Call Vote: Mike Pare aye, Paul Savage aye, Brian Dicks aye, and Diane McCutcheon aye, the Board will return to open session to sign warrants and minutes.

The Board returned to the open session to sign minutes at 9:10 p.m. The meeting adjourned at 9:15 p.m.
