


**TOWN OF MILLVILLE
BOARD OF SELECTMEN MEETING
November 17, 2003**



The meeting duly posted with the Town Clerk, opened at 6:00 PM

Present were: Chairman Diane McCutcheon, Vice Chairman Paul Savage, Brian Dicks, Mike Pare and Tom Petrowicz. Also present were Executive Secretary Suzanne Horne.

Working session with John Dean, also present Joe Lemay who has the plowing contract with the Town. Complaints that snow plowers were not punching in at dispatch but were calling and asking to be punched in. Joe Lemay responded that he is the only one that calls to have his contractors punched in.

On a motion by Brian Dicks seconded by Mike Pare the Board of Selectmen unanimously voted to have the maintenance of time cards and the hours to contractors to be strictly with Joe Lemay; time sheets prepared by Mr. Lemay must be accompanied by time cards signed and verified by Lemay; Mr. Lemay must submit his entire bill including the verified time cards to John Dean, Highway Surveyor who will approve and forward to the Treasurer for payment. Mr Lemay must also forward a current Workers' Comp certificate to the Board. The Board would also like invoices that are submitted to include name of roads that are treated/plowed.

Mr. Barrett of 52 Fisher Street submitted a letter of complaint, dated November 7, 2003, that he requested to be read. Diane McCutcheon, Chairman read the letter to the Board. The letter stated that he, Mr. Barrett, was complaining to the Building Inspector Earl Vater very loudly when Selectmen Pare stepped in and treated him rudely and then called the police on him. He would like to make sure that he receives copies of any police log that has his name on it. When asked what action he would like the Board to take Mr. Barrett responded that he would like it known hoe he was treated and he would like to make sure that he gets copies of the police logs.

The meeting recessed at 7:00 p.m. for the Special Town Meeting.
Meeting reconvened at 8:50 p.m.

Letter from Rep. Callahan inviting the Board to a van tour on November 24, 2003 of several sites in the valley including a stop in Millville for the five bridges that are out to bid.

On a motion by Paul Savage and seconded by Tom Petrowicz the Board voted, 3 for and Brian Dicks and Mike Pare against, to revise the badge policy to state that badges must be with employees at all time while on Town property and to be shown when requested.

On a motion by Tom Petrowicz, seconded by Brian Dicks the Board unanimously voted to have Diane McCutcheon sign Mass Highway contract for \$7,552.00 for location change in communication wires.

On a motion by Brian Dicks seconded by Mike Pare the Board unanimously voted to have Diane McCutcheon sign the extension for the Housing Rehab CDF1 FY02 grant until June 2004.

On a motion by Mike Pare seconded by Brian Dicks the Board unanimously voted to allow Onnies 'n' Nonnies and Century Liquors to be opened and sell liquor on the Sunday before Thanksgiving to the Sunday before New Years.

On a motion by Mike Pare seconded by Brian Dicks the Board unanimously voted to appoint Judith Sambor and Dorothy DiLorenzo to the Cultural Council for three-year terms.

Discussion with Ray Anderson concerning mowing contract with Brian Mullaly; he would like to have input into the next contract.

Meeting adjourned 9:15 p.m.
