REPORTS OF TOWN OFFICIALS

<u>Centennial Celebration Committee</u>. Chairman Jennifer Dean Wing addresses the composition of the current Committee and seeks to change the wording as previously presented to the Board as follows:

On a motion by Rapoza and second by Baker, the Board votes unanimously to accept and approve the revised language creating the Centennial Celebration Committee as follows:

"...that a Committee known as the "Centennial Celebration Committee" be established, composed of eleven (11) regular members to be appointed by the Board of Selectmen on an annual basis each fiscal year and eligible for reappointment each fiscal year, subject to the written recommendation of the Committee based on attendance and participation. Preference will be given to residents, former residents and employees of the Town of Millville. Prospective Committee members shall be recommended, in writing, to the Board of Selectmen by the Committee. A quorum of the Committee shall consist of a majority of the eleven (11) members, being six (6). The Committee may elect its own officers and appoint its own sub-committees as it sees fit. The Committee is established for the purpose of considering and planning the celebration of the Centennial of the incorporation of the Town of Millville and shall provide written reports to the Board of Selectmen for inclusion in the Town's Annual Reports for the years 2012-2016."

EXECUTIVE SECRETARY REPORT

<u>Advertising Costs</u>. Executive Secretary explains that a cost comparison was done of advertising costs between the Milford Daily News and Worcester Telegram & Gazette, a savings of between 37-40%. The Call is higher than the Milford Daily News. Does the Board wish to change newspapers?

On a motion by Rapoza and second by Baker, the Board votes unanimously to change the Town's advertising newspaper to the Worcester Telegram & Gazette effective January 1, 2015.

<u>Departmental Annual Update Reports</u>. Executive Secretary seeks clarification on how the Board would like departments to present annual reports beginning next year...there had been some discussion regarding requiring they present goals going forward. The Board agrees that departments should be given suggested topics but they should not be made mandatory, such as: actions taken during previous year, goals for upcoming year, needs of the department/board going forward; collaboration efforts with other departments.
