**Budget Review** 

Committee was joined by the Town Admin Jennifer Callahan, Chairman of the Board of Selectmen Joe Rapoza, and Town Accountant Justin Cole to discuss the current proposed FY '18 budget deficit of (\$535,112) that the town is facing. To address the deficit the committee has decided that a three pronged approach is the most feasible solution. It includes: additional adjustments to department budgets, to the BMRSD contribution amount, and drawing down various reserves (free cash and stabilization). Currently, the bulk of the deficit lifting is coming from reserves however our Town Accountant Justin Cole strongly suggests a 5% of budget minimum balance in our Stabilization account and the committee wholeheartedly agrees. In order to lessen the draw on reserves, the committee will continue to fine tune the numbers in the hopes of being able to get further adjustments from department budgets while still preserving town and employee morale towards building for our future. The Next Meeting is set for Thursday April 20<sup>th</sup>. The committee also voted unanimously to hold a joint Board of Selectmen Finance Committee meeting on Monday May 1<sup>st</sup> at 7pm to discuss warrants for the upcoming annual town meeting.


