Finance Committee Chairman Paul Ouellette called meeting to order at 7:02 p.m.

**Discussion on Public Information Worksheets**

The Committee reviewed, with the Finance Director Justin Cole, the Levy Limit Calculation worksheet that was made public on the town's website. Committee Member Aubrey Buono suggested adding the \$1 million override figure in year 1 along with some more information to help clarify any confusion town residents are currently having. There was a debate as to whether this was too much information. In the end, the Committee agreed to circulate our suggestions to Justin over the next day and he would work to aggregate them into the worksheet for posting to the town's website.

**Regionalization**

Police Chief Landry presented a comparative analysis of total compensation packages between Blackstone and Millville policemen. This was in response to the Town Administrator of Blackstone suggesting that Millville would be in better financial condition if it merged services with Blackstone. The analysis shows that there are no monetary advantages to having Blackstone assume our police responsibilities. It would be an increase in costs to our townspeople. One suggestion the chief made was to consider regionalizing ambulance services again. It was considered at some point in the past and may be an area of cost savings to the town. That process would take upwards of 2 years to complete.

Our next meeting is scheduled for Thursday June 21, 2018 at 7 p.m. to discuss the warrant article for the special town meeting on Wednesday June 27, 2018.
